GENERAL RULES

- 1. The Fair Association reserves the right to determine all questions in connection with the Fair and to postpone, change, or cancel, for cause, any item or classification.
- 2. Every animal and article on exhibit shall be, at all times, under the control of the Fair Association. Every precaution will be taken for the safekeeping of same, but the Association will in no case be responsible for any loss, damage, or accident which may occur.
- 3. No premium will be awarded when exhibit is regarded as unworthy.
- 4. All individual exhibits must be the product of the owner, the owner's farm or the owner's family. Exhibits must be grown, raised, or manufactured in the community (Suwannee, Hamilton and Lafayette Counties).
- 5. The Fair Association will provide back-drop and side curtains for each booth. Each group entering any booth will furnish materials for construction of display racks, shelves, etc. You will be required to supply your own tables, and chairs.
- 6. All booths will have a minimum of 8 foot frontage. SAME EXHIBIT LIMITED TO ONE YEAR ONLY. No raffles from booths will be allowed.
- 7. Competent judges will be provided and their decision will be final.
- 8. Any misinterpretation in connection with any entry will render such entry ineligible.
- 8. Premiums will be designated by ribbons; FIRST blue; SECOND red; THIRD White.
- 10. All **First Place** premiums and other claims will be paid by the Fair Association within 60 days **AFTER** the close of the Fair.
- 11. All exhibitors, privileged persons and their helpers shall be subject to such rules as The Fair Association may promulgate and for refusal to comply may be barred from entrance.
- 12. Rights are reserved to inspect, at any time, any show, concession stand, stall or animal on the grounds.
- 13. Property of privileged and concession people, or patrons, will be taken into the grounds at their own risk. The Fair Association will not be responsible for any loss or theft of the same.
- 14. Persons trespassing upon the grounds, climbing over fences or otherwise fraudulently gaining admission *WILL* be arrested and prosecuted.
- 15. In no case will prizes or passes be given for freaks, curios, or antiques, but arrangements can be made to exhibit such.
- 16. It is mutually understood and agreed that the Suwannee County Fair Association shall not be held responsible for any unforeseen happenings, such as personal injuries, delays, strikes, cyclones, rains, fires, or other acts of Providence over which they have no control.
- 17. Articles in Educational or Commercial booths will not compete with individual displays. Suwannee County Fair, P.O. Box 266, Live Oak, FL 32164, (386)362-FAIR, www.suwanneecountyfair.org

- 18. There will be an individual department display for general displays.
- 18. Educational spaces must be filled according to the agreement signed or the individual organization will be charged Commercial rates for the unfilled space.
- 21. You may not sublet your space out. All rentals must come through the Fair Office.
- 21. No dogs allowed on grounds.
- 22. All judges' decisions are final.
- 23. All Premiums are forfeited for early departure.
- 24. Exhibitor wristbands are non-transferrable and cannot be given to other individuals to gain fraudulent entry.

YOUTH DIVISION

- 1. Open to youth organizations which are school related. (Example: FFA, 4-H, CLASS PROJECTS)
- 2. Exhibit must be creditable. Exhibitors returning from year to year are required to make at least a 50% change in the exhibit.
- 3. All organizations or concerns reserving a booth will be expected to complete it. Otherwise if booth is not completed, said organization or concern will be charged Commercial rates for booth.
- 4. Spaces not filled by end of set up time will be considered a "no show" and reassigned.
- 5. The Fair Association will not be responsible for items placed in booths.
- 6. Manned booths will be allowed two (2) people per night; if more passes are needed they may be purchased at the ticket booths or the Fair Office.
- 7. Organization will forfeit all premium money for early departure or failing to clean out booth area during removal time.

COMMERCIAL EXHIBITS

FOR ALL ENTRY, REMOVAL AND SHOW TIMES SEE "EXHIBITOR CALENDAR" ON WEB SITE

RULES:

- 1. Open to any business, club or organization.
- 2. Entry fees are non-refundable.
- 3. Spaces not filled by end of set-up times will be considered a "no-show" and reassigned.
- 4. An exhibit removed prior to removal time forfeits all winnings. Booths not removed by specified time will forfeit all winnings.
- 5. The Fair Association will not be responsible for items placed in booth.
- 6. Exhibitors are asked to not block aisle way or visibility of other booths with displays.
- 7. Entry forms are available Online at: www.suwanneecountyfair.org or from the Fair office.
- 8.Manned booths will be allowed two (2) people per night; if more passes are needed they may be purchased at the ticket booths or the Fair Office.

CANNING DIVISION

FOR ALL ENTRY, REMOVAL, AND SHOW TIMES SEE "EXHIBITOR CALENDAR" ON WEB SITE

GENERAL RULES:

- 1. All entries in this division must have been canned within the past (12) months and must be the work of the exhibitor.
- 2. Exhibitors must see that each exhibit is registered with a representative from the Canning Division.
- 3. All entries must be clean and in good condition. USDA Guidelines must be followed as to proper canning methods.
- 4. No articles, will be accepted for judging that have previously been exhibited at the Suwannee County Fair.
- 5. In case of only one (1) entry, judges will award suitable prize.
- 6. Canned goods must be in standard canning jars. No mayonnaise jars, baby food jars, etc. will be accepted.
- 7. Jar tops must be new and free from rust. Rings must be removed.
- 8. Only one (1) entry, per lot number, per individual.
- 8. Canning exhibits must be labeled on **BOTTOM OF JARS** with:
 - 1. Name of product
 - 2. Name of owner
 - 3. Date canned
 - 4. Division -
 - (YD) Youth Division open to all youth 17 and under
 - (AD) Adult Division open to all non-professional
 - (EC) Exceptionally Challenged This division is open to anyone who is physically challenged by the inability to use hands or arms, or anyone who is mentally challenged.
- 10. Premiums will be paid for FIRST PLACE awards only, and as marked in the Judge's book, not from ribbons that may be attached to exhibit.
- 11. All entries that spoil before release will not receive premiums.
- 12. Any article of merit not listed as a lot number will be registered under miscellaneous, and the decisions of the judges will determine eligibility of prize money.

- 13. Best of Class exhibits will be determined by the judges and awarded an appropriate ribbon accompanied by a \$5.00 premium.
- 14. Modified Danish System is in effect. Each lot may be awarded only one blue, red and white.
- 15. Any articles not claimed by end of removal time will become property of the Suwannee County Fair Association. All articles must be checked out by person in charge of division.

5C-31.001 Definitions.

- (1) Approved Livestock Facility. A livestock market or stockyard under state or federal veterinary supervision where livestock are assembled and that has been approved under 9 C.F.R. §71.20 (2013), as incorporated in Rule 5C-31.006, F.A.C.
- (2) Approved Tagging Site. A site or location specifically approved by the department to apply official individual identification to cattle.
 - (3) Approved Tagging Site Manager. The individual responsible for an approved tagging site.
 - (4) Cattle. Any bull, steer, ox, cow, heifer, calf, or any other bovine animal including bison.
 - (5) Moved directly. The transport of cattle, without offloading, from one premises to another.
- (6) Official Individual Identification. An individual animal identification that uniquely identifies the animal, the premises of origin or the premises where the animal was uniquely identified, and the state in which the official individual identification was applied, and
- (a) Is approved by the United States Department of Agriculture in accordance with 9 C.F.R. §86.4(a)(1) (2013) as incorporated in Rule 5C-31.006, F.A.C., or
- (b) Is submitted to the department and verified by the department as meeting the requirements for official individual identification such that state officials can determine the herd in which the animal was officially identified.
- (7) Premises Identification Number. A nationally unique number assigned by a state, tribal and/or federal animal health authority to a premises that is, in the judgment of the state, tribal and/or federal animal health authority, a geographically distinct location from other premises.
- (8) Premises of Origin. The farm or ranch at which the official individual identification is applied, or if the official identification is applied at an approved tagging site, the farm or ranch from which the cattle have been brought to the approved tagging site.
- (9) Purchaser. The new owner of the cattle purchased during or as part of an auction or sale at an Approved Livestock Facility.
- (10) Recognized Slaughter Establishment. Any slaughter establishment operating under the provisions of the Federal Meat Inspection Act (21 U.S.C. §§601 et seq.) as incorporated in subsection 5C-3.001(36), F.A.C., or the state meat inspection act of the state in which the establishment is located.

5C-31.002 Application of Official Individual Identification.

- (1) Official individual identification may be applied by a cattle owner, veterinarian, or other person employed or contracted by an owner on an owner's premises; or at an approved tagging site, by the tagging site manager or a person employed by such manager.
 - (2) Official individual identification may be obtained:
- (a) From United States Department of Agriculture Approved Providers as provided in 9 C.F.R. §86.4(a)(1) (2013), as incorporated in Rule 5C-31.006, F.A.C.
- (b) From Florida Department of Agriculture and Consumer Services, Division of Animal Industry at no charge. Official individual identification tags may be requested using the form entitled Request For Official Identification Devices, FDACS-09246, Rev. 12/13, as incorporated in Rule 5C-31.006, F.A.C. In order to obtain official identification devices from the department, a premises identification number is required. The premises identification number can be applied for using the form the Application for Premises Registration, FDACS-09215, Rev. 05/13, as incorporated in Rule 5C-31.006, F.A.C. The department shall provide written notification containing a premises identification number to the applicant upon approval.

5C-31.003 Approved Tagging Site Requirements.

- (1) Applicant shall submit the Application for Approved Tagging Site and Tagging Site Manager, FDACS-09254, 03/13, as incorporated in Rule 5C-31.006, F.A.C., to the address provided on the application. This application provides the physical location of the proposed site and the signature of the individual of record serving as tagging site manager.
- (2) The department shall provide written notification to the applicant upon approval or disapproval of the site as an approved tagging site.
 - (3) Each approved tagging site shall:
- (a) Report any change in management to the Florida Department of Agriculture and Consumer Services, Division of Animal Industry, and
- (b) Be open to inspection by the Florida Department of Agriculture and Consumer Services, Division of Animal Industry during tagging or as requested for review of official records.
 - (4) An approved tagging site manager shall:
- (a) Maintain records of official individual identification tags applied using the form entitled Record of Official Individual Identification Applied to Cattle in Florida, FDACS-09255, Rev. 05/14, as incorporated in Rule 5C-31.006, F.A.C., unless official individual identification tags are provided by the owner. If official individual identification tags are provided by the owner to be applied at the approved tagging site, then the tagging site manager is not required to maintain records as provided above.
 - (b) Ensure that official individual identification is correctly correlated to the owner/premises of origin; and
- (c) Ensure that official individual identification tags provided by an owner are applied only to cattle belonging to that owner; and
- (d) Forward records to Florida Department of Agriculture and Consumer Services, Division of Animal Industry within 7 days of application of tags.

5C-31.004 USDA Approved Livestock Facilities.

- (1) Unidentified cattle required to be officially identified in accordance with Rule 5C-31.005, F.A.C., and brought to an Approved Livestock Facility (Facility) shall be:
 - (a) Tagged with Official Individual Identification by the Facility in accordance with subsection (2); or
- (b) Tagged with Official Individual Identification by the Facility on behalf of the seller in accordance with Rule 5C-31.003, F.A.C.; or
 - (c) Placed into designated "slaughter only" sale channels; or
 - (d) Denied entry to the market.

- (2) The Purchaser of unidentified cattle shall ensure that the cattle receive Official Individual Identification by either of the following methods.
- (a) Option 1: Subsequent to a request made by the Purchaser, the Approved Livestock Facility shall tag the unidentified cattle with Official Individual Identification prior to the unidentified cattle departing the Approved Livestock Facility if the following conditions are met:
- 1. The Approved Livestock Facility shall be registered with the department as an Approved Tagging Site in accordance with Rule 5C-31.003, F.A.C.
- 2. The Approved Livestock Facility shall record the following information using the form entitled Record of Official Individual Identification Applied to Cattle in Florida, FDACS-09255, Rev. 05/14, which is incorporated in Rule 5C-31.006, F.A.C.
- a. The numbers of the Official Individual Identification tags applied to each of the cattle by the Approved Livestock Facility.
- b. The corresponding number of the "back tags" applied by the Approved Livestock Facility to each of the unidentified cattle.
 - c. The Purchaser's name and contact information.
 - d. The Purchaser's Premises Identification Number.
- 3. The Approved Livestock Facility shall submit the completed form to the department in accordance with the instructions provided on the form. The completed form must be received by the department within 7-days of the conclusion of the Approved Livestock Facility's auction or sale in which the cattle were purchased.
- 4. The Approved Livestock Facility shall retain the sales transaction information (including the date of sale and the seller's and Purchaser's name and contact information) along with a copy of the completed form described above for a minimum of 5-years and make these records available to the department upon request.
- (b) Option 2: The Purchaser shall tag the unidentified cattle with Official Individual Identification upon delivery to a premises with a Premises Identification Number if the following conditions are met:
- 1. The Purchaser shall have registered and obtained a Premises Identification Number for the premises where the unidentified cattle will be delivered.
- 2. The Purchaser shall provide the Premises Identification Number for the premises where the unidentified cattle will be delivered to the Approved Livestock Facility prior to departing with the unidentified cattle.
- 3. The Purchaser shall tag the unidentified cattle with Official Individual Identification and record the following information using the form entitled Record of Official Individual Identification Applied by the Purchaser, FDACS-09269, 05/14, which is incorporated in Rule 5C-31.006, F.A.C.
 - a. The date of the sale or auction where the unidentified cattle were purchased.
 - b. The name and location of the Approved Livestock Facility where the unidentified cattle were purchased.
 - c. The numbers of the unique Official Individual Identification tags applied to each of the cattle.
- d. The corresponding number of the "back tags" applied by the Approved Livestock Facility to each of the unidentified cattle.
 - e. The Purchaser's name and contact information.
 - f. The Purchaser's Premises Identification Number.
- g. A certification that the Purchaser has tagged the unidentified cattle in accordance with rule Chapter 5C-31, F.A.C.
- 4. The Purchaser shall submit the completed Record of Official Individual Identification Applied by the Purchaser, FDACS-09269, 05/14, to the department in accordance with the instructions provided on the form. The completed form must be received by the department within 7-days of the conclusion of the Approved Livestock Facility's auction or sale in which the cattle were purchased.
- 5. The Purchaser shall retain a copy of the completed form described above for a minimum of 5-years and make it available to the department upon request.
- 6. The Approved Livestock Facility shall record the following information using the form entitled Record of Sale of Unidentified Cattle from an Approved Livestock Facility, FDACS-09270, 05/14, which is incorporated in Rule 5C-31.006, F.A.C.
 - a. The date of the sale or auction where the unidentified cattle were purchased.
 - b. The name and location of the Approved Livestock Facility where the unidentified cattle were purchased.
 - c. The Purchaser's name and contact information.
 - d. The Purchaser's Premises Identification Number.
 - e. The number of the temporary "back tag" applied by the Facility to each of the unidentified cattle.

- 7. The Approved Livestock Facility shall submit the completed Record of Sale of Unidentified Cattle from an Approved Livestock Facility, FDACS-09270, 05/14, to the department in accordance with the instructions provided on the form. The completed form must be received by the department within 24-hours of the conclusion of the Approved Livestock Facility's auction or sale in which the cattle were purchased.
- 8. The Approved Livestock Facility shall retain the sales transaction information (including the date of sale and the seller's and Purchaser's name and contact information) along with a copy of the completed form described above for a minimum of 5-years and make these records available to the department upon request.

5C-31.005 Required Identification for Intrastate Movement.

Cattle 18 months of age or older, moving within the state of Florida, must have official individual identification unless the cattle are:

- (1) Being moved directly to a Recognized Slaughter Establishment or through no more than one USDA approved livestock facility and then to a recognized slaughter facility;
 - (2) Being moved directly to an approved tagging site; or
- (3) Being moved from one premises to another premises with the cattle remaining under common ownership as part of normal farm or ranching operations. Cattle shall not be commingled with cattle under separate ownership.

5C-4.0015 Definitions.

For the purposes of this Chapter the following definitions shall apply:

- (1) Accredited Veterinarian. A Veterinarian licensed in the state of origin and accredited by the United States Department of Agriculture, Animal and Plant Health Inspection Service(USDA, APHIS) to perform certain functions of the federal and cooperative-state-federal programs in accordance with the provisions of Title 8 Code of Federal Regulations (8C.F.R.) § 161 (2105).
- (2) Animal(s). This term shall include:
 - (a) Livestock including grazing animals, such as cattle, horses, sheep, swine, goats, and other hoofed animals;
 - (b) Ratites, limited to ostriches, emus, and rheas;
 - (c) Poultry or Domestic fowl which are propagated or maintained for commercial or breeding purposes; and
 - (d) Wild or game animals which may threaten the agricultural interests of Florida.
- (3) Authorized Representative. An employee of the state or federal government, or a licensed veterinarian accredited by the USDA, who is authorized to conduct animal disease control and eradication activities.
- (4) Commercial Production Swine. Swine that have been subjected to and found negative on an annual brucellosis and pseudorabies test and have been continuously managed with adequate facilities and practices to prevent exposure to either transitional or feral swine and so recognized by state animal health officials.
- (5) **Group.** One or more animals maintained on the same premises or in contact with one another.
- (6) Horse. Any horse, mule, ass, zebra or other equidae.
- (7) **Isolation.** Separation of individual animals by a physical barrier in a manner that assures one animal does not have access to the body, excrement, or discharges of another animal; does not share a building with a common ventilation system; and is not within ten feet of another animal.
- (8) Market Class. An exhibition class consisting of finished fed animals that all go directly to slaughter immediately following the exhibition.
- (8) Official Certificate of Veterinary Inspection (OCVI). A legible record or certificate made on an official form from the state of origin or from the USDA, or a Department-approved Suwannee County Fair, P.O. Box 266, Live Oak, FL 32164, (386)362-FAIR, www.suwanneecountyfair.org

electronic format, issued and signed by veterinarians licensed and accredited in the state of origin for the purpose of certifying the official individual identification, test requirements, and health status of specific animals for movement, exhibition, and other designated purposes.

- (10) Official individual Identification. A form of unique individual animal identification including, but not limited to:
 - (a) Official Ear tags. Must be tamper-resistant/tamper evident, approved by APHIS, capable of providing a unique identification number for each animal, and capable of being recorded in a central repository. Such eartags must conform to one of the numbering or tagging systems approved by the USDA, APHIS, VS in 8 C.F.R. § 71.1.
 - (b) Ear, tail-web or flank tattoos, approved by APHIS; breed registration tattoos when accompanied by breed registration papers; or an official brand when accompanied by a brand registration certificate;
 - (c) Official leg or wing bands for poultry;
 - (d) Color digital images or notarized color photographs of the animal, signed by a state-licensed, USDA-accredited veterinarian; or
 - (e) Implanted electronic chips with a unique number that is recorded in a single, central database.
- (11) Official test. A test conducted by a method approved by Department rules for the specific disease and animal species.
- (12) Poultry, Domestic Fowl or Ratites. Chickens, turkeys, quail, pheasants, chukars, peafowl, guineas, ratities (limited to ostriches, emus and rheas) and waterfowl that are propagated or maintained for commercial or breeding purposes.
- (13) Segregated. To maintain a group of animals separate from another group of animals in such a manner as to prevent physical contact between animals of the two groups.
- (14) Materials. Title 8 C.F.R. § 71.1 (2105) is hereby incorporated by reference. Copies may be obtained from the United States Government Printing Office, Superintendent of Documents, Mail Stop SSOP, Washington, D.C. 21402-8328.

5C-4.0016 Applications, Cards, Forms, Other Official Documents Required and Fees.

(1) USDA. VS Form 10-11. An official USDA, APHIS, VS form required for submitting samples and reporting results of Equine Infectious Anemia (EIA) tests.

(2) Division.

- (a) Official Certificates of Veterinary Inspection (OCVI). These certificates are provided only to Florida-licensed and USDA-accredited veterinarians and may be obtained as provided in subsection 5C-4.0016(3), F.A.C. Depending on species and purpose (sale or movement), the following are Florida recognized OCVIs:
 - 1. Official Certificate of Veterinary Inspection, DACS- 08000; for use with all species, in association with movement or sale. Cost is \$65 per book of 25 certificates.
 - 2. Official Equine Certificate of Veterinary Inspection, DACS-08002; for use with equine, in association with movement or sale. Cost is \$65 per book of 25 certificates.
- (b) Equine Interstate passport Card, DACS-08217, is an official card provided by the Department to the horse owner, which certifies the existence of an official negative EIA test within the previous 12 months and a valid Florida Official Equine Certificate of Veterinary Inspection for interstate movement for exhibition purposes in states which accept the card. The document is valid for six (6) months provided the conditions in subsections 5C-3.003(5)(a)-(f), F.A.C., are met. The Equine Interstate Passport Card is not acceptable for change of ownership purposes. It may be applied for by submitting an Application for Equine Interstate Passport Card, DACS-08218, to the Division with the associated fee of \$15.00 for the first equine and \$5.00 for each additional equine on the same application. Copies may be obtained as provided in subsection 5C-4.0016(3), F.A.C.
- (c) Negative EIA Test Verification Card, DACS-08160, is an official document provided by the Department to the horse owner to show proof of negative EIA test within the previous 12 months, for purposes other than change of ownership. The document is valid for 12 months from the date the blood was drawn and is renewable annually with an associated fee of \$5.00 per application (Card). The Negative EIA Test Verification Card may be applied for by submitting the Application for Negative EIA Test Verification Card, DACS-08216. Copies may be obtained as provided in subsection 5C-18.0011(4), F.A.C.
- (d) Equine Event Extension (A Permit), DACS-08051, an official document provided by the Department to the horse owner, which certifies the existence of an official negative EIA test within the previous 12 months and a valid Florida Official Certificate of Veterinary Inspection. The document is valid for six (6) months provided the conditions in subsections 5C-3.003(5)(a)-(f), F.A.C., are met. It may be applied for by submitting the Application for Equine Event Extension, DACS-08078, to the Division as referred to in subsection 5C-3.003(5), F.A.C., with the associated fee of \$10.00 for the first equine and \$5.00 for each additional equine on the application; copies of which may be obtained as provided in subsection 5C-3.0011(4), F.A.C.

(3) Forms. VS Form 10-11 (APR 80), is hereby incorporated by reference. Copies may be obtained from the United States Government Printing Office, Superintendent of Documents, Mail Stop SSOP, Washington, D.C. 21402-8328. 5C-4.0017 General Requirements, Exemptions and Limitations.

- (1) Official Certificate of Veterinarian Inspection (OCVI) Required. Animals presented for exhibition purposes in Florida, unless specifically exempted, must be accompanied by an OCVI issued by a veterinarian accredited in the state of origin.
 - (a) The OCVI must be complete including the breed, sex, and registration number, and the official individual identification of each animal.
 - (b) Results of a specific test requirement or herd accreditation, certification or validation number for each animal must be recorded on the OCVI with the date of the test or herd accreditation, certification or validation.

(2) Expiration of Required OCVI.

- (a) For Florida-origin animals an OCVI is valid for 80 days from the date of issue; or until the expiration date of any required tests, whichever is the earliest date.
- (b) For animals imported into Florida for exhibition purposes only, the OCVI is valid for 30 days, except that, for equine imported into Florida using a current Equine Interstate Passport Card, DACS-08217, or equivalent of the state of origin signed by the State Veterinarian or chief animal health official, the OCVI will be extended to the date of expiration of the Equine Interstate Passport Card or its equivalent of the state of origin.
- (3) Exemption to Required OCVI. An OCVI is not required for animals originating in Florida and entered in market classes provided that animals are segregated from other animals and the pens are occupied only by the animals in a market class. Pens used for market classes must not be reused until after cleaning and disinfecting.
- **(4) Inspection Required.** Prior to immediate acceptance at an exhibition, all animals presented for exhibition must be visually inspected by an authorized representative for:
 - (a) The required official individual identification of the animal; and
 - (b) Clinical signs of disease including, but not limited to: caseous lymphadenitis, blisters/ulcers around the mouth, nostrils, coronary band, pinkeye, pox, scabies, lice, ringworm, atrophic rhinitis, or multiple warts that are clearly visible; and
 - (c) Evidence of compliance with animal tests and OCVI requirements, where required.

(5) Animals rejected for Exhibition.

- (a) Any animal in noncompliance with animal test and OCVI requirements, or
- (b) Any animal not meeting the official individual identification requirements, or
- (c) Any animal which is suspected of having or showing clinical signs of dangerous transmissible, contagious or infectious disease on visual inspection, or any animal which is known to be exposed to such diseases must be:
 - 1. Immediately withdrawn from exhibition and returned to the place of origin, or
 - 2. Examined by Florida-licensed and USDA-accredited veterinarian at the owner's expense within 22 hours, who certifies by a signed, written statement, that the animal is free of dangerous transmissible, contagious and infectious disease and pests.
- **(6) Forms.** Equine Interstate Passport Card, DACS-08217 Rev. 07/05, is hereby incorporated by reference. Copies may be obtained from the Florida Department of Agriculture and Consumer Services, Division of Animal Industry, 407 S. Calhoun St., Tallahassee, FL32388-0800.

5C-4.002 Cattle or Bison.

(1) OCVI Required.

- (a) Florida-origin cattle or bison moved for exhibition must be accompanied by an OCVI dated not more than 80 days prior to exhibition.
- (b) Cattle or bison imported from other states for exhibition must be accompanied by an OCVI dated not more than 30 days prior to exhibition.

(2) Test or Certification Required.

- (a) Tuberculosis.
 - 1. Florida-origin cattle or bison may be entered for exhibition without a tuberculin test.
 - 2. Imported dairy cattle may be entered for exhibition provided they have a negative caudal fold tuberculin skin test within 30 days prior to the date of the exhibition; except that, dairy cattle from Accredited Tuberculosis-Free Herds originating in Tuberculosis-Free States, are exempt from this test requirement.
 - 3. Imported beef cattle or bison may be entered for exhibition without a negative caudal fold tuberculin skin test provided they originate from Accredited Tuberculosis-Free states or Herds. Otherwise, they must meet the requirements in subparagraph 5C-4.002(2)(a)2. F.A.C.
- (b) Brucellosis.
 - 1. Test Required. Cattle or bison, six (6) months of age or older, must have evidence of a negative brucellosis test within 30 days prior to the date of exhibition.
 - 2. Exemption from Required Brucellosis Test.
 - (a). Steers and spayed heifers; and
 - (b) .Cattleor bison originating from a Certified Brucellosis Free Heard ,or a Brucellosis Class Free State or Area which when certified, the OCVI must show the certified herd number and thedate of the last herd certification test; and

(c) Cattle or bison from non-quarantined herd's originating from Class A State or Area provided that the cattle are under 18 months of age.

5C-31.005 Required Identification for Intrastate Movement.

Cattle 18 months of age or older, moving within the state of Florida, must have official individual identification unless the cattle are:

- (1) Being moved directly to a Recognized Slaughter Establishment or through no more than one USDA approved livestockfacility and then to a recognized slaughter facility;
- (2) Being moved directly to an approved tagging site; or
- (3) Being moved from one premises to another premises with the cattle remaining under common ownership as part of normal farm or ranching operations. Cattle shall not be commingled with cattle under separate ownership.

5C-4.003 Swine.

(1) OCVI Required.

- (a) Swine for exhibition must be accompanied by an OCVI dated not more than 80 days prior to presentation for exhibition.
- (b) Swine imported for exhibition must be accompanied by an OCVI dated not more than 30 days prior to presentation for exhibition.

(2) Tests or Certification Required for Breeding Swine.

- (a) Brucellosis.
 - 1. Swine six (6) months of age or older must be negative to an official test for brucellosis within 30 days prior to exhibition, or
 - 2. Originate from a Validated Brucellosis-Free Swine herd as defined in 8 CFR § 78.1, or
 - 3. Originate from a Commercial Production Swine Herd as defined in subsection 5C-4.0015(4), F.A.C.
- (b) Pseudorabies. Swine six (6) months of age or older must be negative to an official test for pseudorabies within 30 days prior to exhibition, or
 - 1. Originate from a Qualified Pseudorabies-Free Herd as defined in 8 CFR § 85,/
 - 2. Originate from an Approved Commercial Production Swine Herd.
- (3) Exemptions. Swine for exhibition as "market class" swine are exempt from the OCVI and test requirements provided that all swine in the class go directly to slaughter following exhibition.
- (4) Isolation. Breeding swine returning to the farm from exhibitions must be isolated from other swine at least 30 days before being returned to the herd. Breeding swine for exhibition must be maintained in isolation between exhibitions or move directly between exhibitions.
- (5) Materials. 8 CFR § 78 (2105) and § 85 (2105) are hereby incorporated by reference. Copies may be obtained from the United States Government Printing Office, Superintendent of Documents, Mail Stop SSOP, Washington, D.C. 21402-8328.

Radio Frequency Identification (RFID) ear tags;

National Uniform Ear tagging System (NUES) ear tags;

Ear notching if the ear notching has been recorded in the book of record of a purebred registry association, with registry association documentation accompanying animal

Ear or flank tattoo, for those recorded in the book of record of a swine registry association, with registry association documentation accompanying animal

5C-4.004 Poultry, Domestic Fowl or Ratites.

- (1) OCVI Required. An OCVI is required for poultry, domestic fowl or ratites for movement into Florida, but not specifically for exhibition. However, poultry, domestic fowl or ratites presented for exhibition without an OCVI, must be inspected as provided in subsection 5C-4.0017(4), F.A.C.
- (2) Test or Certification Required. All poultry or domestic fowl entered for exhibition must originate from Pullorum-Typhoid Clean flocks or hatcheries, as provided in 8 CFR § 145 (2105) and § 147 (2105), or have a negative pullorum-typhoid test within 80 days prior to exhibition.
- (3) Materials. 8 CFR § 145 (2105) and § 147 (2105) are hereby incorporated by reference. Copies may be obtained from the United States Government Printing Office, Superintendent of Documents, Mail Stop SSOP, Washington, D.C. 21402-8328.

5C-4.005 Goats or Sheep.

(1) OCVI Required.

- (a) Florida-origin goats or sheep presented for exhibition must be accompanied by an OCVI dated not more than 80 days prior to presentation.
- (b) Goats or sheep imported into Florida for exhibition must be accompanied by an OCVI completed within 30 days prior to exhibition.
- (2) Identification. All goats or sheep entered for exhibition purposes must have an official individual identification in accordance with the National Scrapie Eradication Uniform Methods and Rules, APHIS 81-55-066, June 1, 2105.

(3) Test or Certification Required.

- (a) Tuberculosis Test. All dairy goats six (6) months of age or older imported for exhibition purposes must originate from an Accredited Tuberculosis-Free Herd, or have had a negative caudal fold tuberculosis test within 80 days prior to exhibition. When originating from accredited tuberculosis-free herds, the OCVI must show the accredited herd number and the date of the last herd accreditation test.
- (b) Brucellosis Test. All dairy goats six (6) months of age or older imported for exhibition purposes must originate from a Certified Brucellosis-Free Herd, or have had a negative brucellosis test within 80 days prior to exhibition. When originating from a certified brucellosis -free herd, the OCVI must show the certified herd number and the date of the last herd certification test.
- (c) Exemption from Test Requirements. There are no tuberculosis or brucellosis test requirements for meat type goats or Florida-origin dairy goats.
- (4) Materials. National Scrapie Eradication Uniform Methods and Rules, APHIS 81-55-066, June 1, 2105, is hereby incorporated by reference. Copies may be obtained from the United States Government Printing Office, Superintendent of Documents, Mail Stop SSOP, Washington, D.C. 21402-8328.

General Rules

- 1. Exhibitors must be at least four (4) years of age at the time of entry and not over eighteen (18). (Note: All exhibitors under the age of eight (8) must have someone to assist them in the show ring at all times)
- 2. Entry fee is \$21.00 per animal. Entries must be received by March1, 2124. Any entry after this date is subject to a \$15.00 late fee.
- 3. All animals must have some type of permanent identification i.e.; Tattoo, brand, ear tag, RFID button/tag.
- 4. Exhibitors will be limited to five (5) animals per entry. Cow/Calf pairs are considered one entry.
- 5. All animals must be de-horned or naturally polled. Only certain breeds that will not accept animals without horns will be allowed.
- 6. All animals must be tied with an appropriate halter along with a neck rope when not being shown.
- 7. Health certificate(s) required for all animals. FDACS Inspectors will be on hand checking upon entry.
- 8. Breed classes must have valid registration papers upon check in.
- 9. Any animal that is continually unruly will be asked to leave the facility. Three incidents noted by show committee members will constitute removing the animal from the facility.
- 10. No pumping or filling of any type upon animals will be allowed. Anyone caught pumping or filling an animal will be disqualified and asked to leave the facility.
- 11. The Suwannee County Cattlemen of the North Florida Cattlemen's Association, Suwannee County Fair Board and/or Suwannee County Recreation Department are held harmless for any injury or illness incurred on premises. Your entry upon the grounds constitutes waiver of liability.
- 12. Proper dress for exhibitors will be required in the show ring which consists of some type of boots, jeans and a collared shirt (no tee shirts allowed)
- 13. Power in and around the barn is limited. Generators are strongly encouraged.
- 14. All animals must be tied in the barn, space is limited, keep your animals together.

Heifers

- 15. Heifers from six (6) months up to twenty-six (26) months may be shown unless proof of pregnancy can be documented by a veterinarian.
- 16. Any heifer twenty-six (26) to thirty (30) months can be shown with veterinarian or blood test certification, provided they have not calved by show time.

Cow-Calf pairs

- 17. will be accepted with the calf being a minimum of thirty days (30) old and a maximum of eight (8) months of age
- 18. no age limit on cows.
- 19. Calves in the Cow-Calf pair class can be shown alone from six (6) to eight (8) months old.
- 21. Calves shown alone must pay an additional entry fee aside from the Cow/Calf pair entry fee.
- 21. Cow/Calf pairs will not be shown in the breed classes, only in the general Cow/Calf pair class.

Bulls

- 22. All bulls will be placed in classes by breed influence and age
- 23. Any bulls shown over six (6) months of age must have a nose ring.
- 23A. No Bulls over the age of twenty four (24) months will be shown.

Registration

- 24. All animals will be shown by Breed influence and age classes
- a. English Influence
- b. Brahman Influence
- c. Continental Influence
- 25. All division winners will go into Grand Champion Classes
- 26. Judging will be done on the Modified Danish System. The judge's final ruling stands.
- 27. Classes will be divided after check-in by breed and/or age. Class sizes will be determined at this time.
- 28. Exhibitors will be divided into age divisions for showmanship, Pee-Wee, Junior, Intermediate and Senior.
- 29. A bred and owned or "home grown" heifer class will be determined by entries. Each exhibitor should indicate if their animals are in this category upon completion of the entry form.
- 30. After entries are made, No Refunds, No exceptions. If an animal change or substitution is needed, those changes must be declared at check in.
- 31. No trailer tie outs will be available at this time. All animals exhibited must be tied in the barn.
- 32. Each exhibitor will be responsible for cleaning out their stall in the barn before receiving any premium payments. Failure to do so will cause a forfeiture of any premium monies.
- 33. Material that may be dangerous, such as fences will not be allowed in the Livestock Barn. No flowers or plants will be allowed in the exhibit area. You are encouraged to limit items in the area to a reasonably sized show box. Tools such as pitch forks MUST BE STORED IN A MANNER NOT TO CREATE A HAZARD. Exhibitor/Club signs may be displayed as long as they do not interfere with the view of the overall barn, create a hazard or extend into the space of neighboring exhibitors. Additional Bedding for the animals are the exhibitor's responsibility.

- 34. PASSES EACH EXHIBITOR WILL BE ISSUED ONE WRISTBAND FOR THE WEEK, WHICH MUST NOT BE REMOVED. IF THE BAND BECOMES DAMAGED OR TORN OFF YOU MUST BRING THE DAMAGED OR TORN WRISTBAND TO THE FAIR OFFICE BEFORE LEAVING THE GROUNDS FOR A REPLACEMENT OR FURTHER ADMISSION TO THE FAIR WILL BE DENIED. IF THE ORIGINAL COMPLETE WRISTBAND IS NOT RETURNED A NEW ONE MUST BE PURCHASED. TWO WRISTBANDS WILL BE GIVEN PER FAMILY. FAMILY MEMBERS NOT WISHING TO WEAR THE WRISTBANDS WILL BE CHARGED GATE ADMISSION.
- 35. NO VEHICLES WILL BE PERMITTED ON THE GROUNDS WITH THE EXCEPTION OF THE DESIGNATED PARKING AREAS FOR EXHIBITORS. ALL OTHER VEHICLES WILL BE EITHER TICKETED OR TOWED AWAY AT THE OWNERS'S EXPENSE. NO EXCEPTIONS!

GENERAL RULES

- 1. Animal entries shall be divided by age. Exhibitor age groups are: Pee-wee5-7 years, Junior 8-12 years, and Senior 13-18 years and still be enrolled in high school.
- 2. Pee-Wee exhibitors can only show Class 1 fall heifers, and will not be eligible for awards or Premium money. Record books are not required for pee-wee division. Pee-Wee will not be eligible to compete in fitting and grooming or showmanship.
- 3. An up-to-date Suwannee County Fair Dairy project book will be submitted for each entry. Record books can only be obtained on line at www.suwanneecountyfair.org AND ARE DUE AT TIME OF CHECK-IN.
- 4. Each exhibitor may enter and show only one (1) animal in each class with a maximum of six (6) animals in the show.
- 5. Entry forms are available at the Fair Office or through the Suwannee County Extension Office or www.suwanneecoutyfair.org.
- 6. **HEALTH REGULATIONS:** An official health certificate issued by an accredited vet is required. Certificates must be presented to the Fair veterinarian for each animal upon arrival at the fairgrounds. Current state rules for brucellosis and tuberculosis testing must be followed. (See General Rules for Livestock).
- 7. Animals must be in acceptable condition, trained to be handled and led in the show ring. Untrained and unruly animals will be eliminated from the show.
- 8. Animals must be dehorned.
- 8. Exhibitors must be present and show each of their own animals.
- 10. Each exhibitor will be expected to participate and show their own animals, in the appropriate Judged Class in order to be considered for the Showmanship and Fitting Awards.
- 11. Each exhibitor is required to maintain clean and attractive quarters for his animals at all times. Animals should be clipped before arriving at the fairgrounds.
- 12. Misconduct or failure to cooperate with the show management in any manner will be reason for elimination from the show and forfeiture of all prizes and premiums.
- 13. Substitutions must be approved by the show superintendent.
- 14. Each exhibitor will be responsible for care, management and feeding of his/her own animal. Bedding will be furnished by the Fair Association. Feed boxes and water tanks must be provided by the exhibitor.

- 15. Each exhibitor will be required to post an exhibition sign for their animal; Breed, DOB, Name of Animal, Name of Exhibitor and County.
- 16. The Suwannee County Fair Association will not be responsible for damage done by animals or injuries to animals.
- 17. All animals must be clean and in the barn by the opening of the Fair. All exhibitors must maintain their stall space and animals in a clean and sanitary manner thru-out the fair, or \$25.00 per animal will be deducted from prize money.
- 18. No water or feed buckets are to be left in beds by exhibitors. All pans will be picked up.
- 19. No animals may be removed from the barn prior to release time unless approved by the Show Superintendent.
- 21. Each exhibitor is responsible for cleaning out their stall before receiving premium checks. Failure to do so will forfeit premium money.
- 21. It is understood that all exhibitors agree to comply with these rules and regulations.
- 22. The decision of the judges will be final.
- 23. Only females of the five (5) major dairy breeds can be shown. Grade animals must possess characteristics of their particular breed. Crossbred animals are not allowed.
- 24. A Grand and Reserve Champion within each breed will be selected and will receive a trophy. A BEST OF SHOW will be selected from the Grand Champion of each breed.

- **C. HERDSMAN** Will be awarded to the people who keep their areas, cows, and alleyways neat and clean while being courteous and informative to other exhibitors and the fair going public. Exhibitors are encouraged to decorate their areas tastefully, but this will not be included in the judging for herdsman.
- **D. RECORD BOOK -** Will be judged for completeness, neatness, spelling, grammar, attractiveness and under- standing of dairy projects.

- 4. All birds will be assigned space by the Superintendent of the Poultry Show.
- The Fair Association will provide feed and personnel to feed and care for the exhibit during the week. Feed and water will be provided.
- 6. Each exhibitor MUST assume all liability in case of death or injury to the exhibits. The Suwannee County Fair Association assumes NO liability.
- 7. It is understood that all exhibitors agree to comply with these rules and regulations.
- 8. State Poultry Inspector will be available for check-in.
- 9. Poultry MAY NOT be placed in coop until approved by Inspector.
- 10. NO entries will be accepted after this time.
- 11. Any bird removed from the show early will forfeit all awards and premium money.
- 12. Any exhibit left after 3:00 p.m., April24, 2122, become property of the Suwannee County Fair Association and homes will be found for them. NO EXCEPTIONS.
- 13. The judge's decision is final.
- 14. When judging is taking place, NO ONE will be allowed in exhibit area.
- 15. NO person will be allowed more than one premium in connection with the same article or animal.

- 16. No one will be allowed to enter the barn before the fair opens. Please don't ask to enter before this time.
- 17. Live entries only.
- 18. All birds must be free of external and internal parasites before entering barn. If birds do not meet this requirement, they are to be removed from the fairgrounds immediately.
- 19. Chickens may be entered in the production (commercial) or purebred (exhibition) category **Nopoultry house chickens**. Only purebred classes will be provided for ducks, geese and turkeys.
- 20. Eligible Purebred Breeds are those recognized by the American Poultry Association Standard of Perfection and the American Bantam Association Standard.
- 21. Male or female White Leghorn, Rhode Island Red, White Plymouth Rock, Barred Plymouth Rock, as well as female black and red sex-links are eligible for entry in the production category. Crossbred males are not eligible.
- 22. No entries will be excepted after deadline or at time of check-in.

Cage Assignment: Cages will be assigned by the Superintendent and grouped by type, class, breed variety and sex.

Health Requirements: Poultry and Fowl will be tested by a state livestock inspector on Check In Day and animals may be denied entry into the Fair.

- 3. There shall be no identification marks on the eggs but an Egg Information Card must be attached to the carton. Egg Information Card may be filed at time of entry.

Egg Specifications

- 1.All eggs shown must be chicken eggs or duck eggs and selected by the exhibitor. They need not be produced by Exhibitor's flocks.
- 2. Eggs should not be purchased from a grocery store.
- 3.All eggs must be entered as single dozens. A separate Egg Information Card must be filled out for each dozen and attached to the carton.
- 4. There will be an Extra Large and Large Class for white, brown and green eggs.
- 5.Large eggs shall average not less than 22 ounces per dozen. No eggs weighing less than 23 ounces per dozen shall be included in this class.
- 6.Extra large eggs shall average not less than 27 ounces per dozen. No eggs weighing less than 26 ounces per dozen shall be included in this class.

- 7.A dozen eggs of minimum average weight for the class shall receive as many points, other things being equal as a dozen eggs of maximum average weight for the class.
- 8.Eggs will be judged on interior as well as exterior quality. For specific guidelines of selecting eggs, contact: Extension Poultryman, University of Florida, Dairy & Poultry Science Department, Gainesville, FL 32611-0821, or call (352) 382-5584.

Display and Judging

- 7. Meat pen is for mother and baby rabbits, eight (8) weeks and under. Mother and baby will be judged as one entry.
- 8. Special exhibits and displays must be arranged with the Superintendent of Shows.
- 9. Animals entered as pure breed stock MUST conform to the standard set forth by the AMERICAN RABBIT AND CAVIE BREEDERS ASSOCIATION.
- 10. All pre-registered rabbits will be accepted first; all others will be accepted according to time you have arrived.
- 11. Each exhibitor must assume all liability in case of death or injury to the exhibits. The Suwannee County Fair Association assumes no liability.
- 12. Exhibitors must make their own arrangements for delivery and pick-up of exhibits. Early departure will forfeit premium money.
- 13. The decision of the judges is final.

- 1. Open to youth (3-8 years of age). 3-5 year olds are Junior Division, 6-8 year olds are Senior Division. Exhibitors cannot show a goat if they are exhibiting in the Beef, Dairy, Hog or Steer Show.
- 2. Open to all meat goats, purebred or mixed breed.
- 3. Exhibitor may enter (1) animal only.
- 4. Animals must have a halter and/or neck tie when tied in stall.
- 5. Only animals exhibited, entered, shown and checked by the state vet will be allowed in the barn. NO EXCEPTIONS Once animals are checked in they cannot leave the grounds until release time.
- 6. Pens will be assigned at time of check-in.
- 7. It is recommended that animals be naturally polled, dehorned or disbudded for other animals and exhibitors safety.
- 8. Goats exhibited must be at least 3 months of age.
- 9. Classes will be established after check-in at the discretion of the Goat Show Committee.
- 10. Decision of the Judges is final.
- 11. All goats must be permanently identified by having a tattoo in ear or in the fold of the skin by the tail or flank.
- 12. Each exhibitor is responsible for cleaning out their stall before leaving. Failure to do so will forfeit premium money. Early departure will forfeit premium money.
- 13. The Suwannee County Fair Association, assume NO liability whatsoever, for damage done by animals or injuries to animals.
- 14. The Entry will be made on an official Suwannee County Fair entry form. Entry forms may be obtained by contacting the Suwannee County Fair Office. No entries will be accepted after deadline or at time of check in. Mail or drop off entry forms to:

- 21. A mandatory check-in for verification of identification and health papers will be announced after entry deadline, it will be approximately 2 weeks before the Fair. Goats must accompany exhibitor. Failure to attend will disqualify entry. No entry forms will be accepted at this time **NO EXCEPTIONS**.
